## Food & Beverage Discounts

Members using the card are able to benefit from a 20% discount on their spend in all the group restaurants and bars as well as on take away service within the Resorts;

### **Restaurants included**

Flavours, Agliolio, The Lagoon Bar & Restaurant, Essence Restaurant, Dunes Cocktail Bar, Mokka Lobby Lounge and Swizzles Bar at the Radisson Blu Resort & Spa, Golden Sands; The Kontiki Restaurant, Le Bistro, The Edge, The Bridge Bar , Ritter's Cafe and the Wet Bar at the Radisson Blu Resort, St Julian's.

The discount amount is extended on the purchase of both food & beverage whether combined or independently. Discounts will only be applicable if the client presents his/her card which must be swiped in order for the discount to be effective.

### **Exclusions**

Discounts are not applicable on Easter Sunday, Mother's Day, Father's Day, Valentine's Day, from the 18th December till the 3rd January, on mini bar sales at all Resorts and at the Deli at the Radisson Blu Golden Sands Resort & Spa.

- This is valid for groups not exceeding 25 persons at the same time.
- One card is to be presented per table.

## Complimentary Dinner Voucher

Members will receive a voucher for a complimentary buffet dinner for the member to make use of from Monday to Friday in either Flavours or Kontiki.

- Beverages and Wine are not included with this voucher.
- Bookings need to be made through the Elements office.
- The Card cannot be used in conjunction with the voucher.
- The same date limitations are applicable on the vouchers as with the use of the card.

## Accommodation Discount

Members are entitled to a 25% discount on the retail rate on accommodation at Radisson Blu Resort & Spa, Golden Sands and the Radisson Blu Resort, St Julian's.

The discount is calculated as a percentage off the retail rate for booking dates as stipulated at the time of purchase. Accommodation purchase made in this manner require the member to confirm the reservation with Credit Card details and cancellation will carry a penalty of one night if the cancellation is carried out within 24 hours of the arrival time.

## Accommodation Vouchers

Gold Members will be entitled to two overnight-night stay vouchers valid for a complimentary night stay when booking a minimum of two nights. The second night will be charged at a special discount of 30% off the hotel retail rate of the day.

The voucher is inclusive of breakfast and is valid for the room type booked for the paying night. The voucher is valid for two persons, accompanying third or fourth persons will be charged at the standard published rates.

Reservations for use of this voucher must be made through the Elements Office a maximum of three weeks prior to the booking dates requested. Reservations are subject to availability and Elements programme allocation.

The use of the night voucher must be notified at the time of reservation and the voucher must be presented at check-in at the respective hotel. The vouchers have an expiry period of one year from the date of issuing.

The night vouchers are fully transferable and are not valid for use in conjunction with other special rates, discounts or promotions.

### **Exclusions**

Accommodation Vouchers are not acceptable from the 10th until the 25th August, from the 18th December to the 3rd January.

## Private Event Catering

The Member will benefit from a 5% discount on any personal events booked using our Meeting and Events Teams within the Hotels or through Island Caterers. In the case of Outside catering discounts can only be applied on food& beverage purchased from the company and does not extend to venue hire charges or corkage fees.

## Gold Points Plus

Members will be automatically enrolled in Goldpoints Plus, an international point's programme extended through all Carlson International and Rezidor Hotels.

Membership in this programme will allow guests to earn and redeem points both locally as well as internationally and exchange these points across the entire network; benefits extend to Radisson Blu Hotel & Resorts, Radisson Hotels, Park Inn Hotels, Country Inn Hotels, Park Plaza Hotels, Regent Hotels & Resorts as well as Hotel Missoni.

## Health & Fitness

The Member will be enrolled as a member with Myo ka Spas and can benefit from a 20% discount on individual treatments at all Myo Ka Spas in Malta. Discounts are not valid in conjunction with other special rates, discounts or promotions. The member must notify spa management of the use of the discount at the time of booking.

- Members will benefit from a 15% discount on the Gym Membership at the Radisson Blu Resort, St. Julian's.
